# Jacob Gelt Dekker's book 'The Caribbean' presented

AMSTERDAM--The new book of well-known Dutch entrepreneur, philanthropist and writer Jacob Gelt Dekker, who has been residing in Curação for many years, titled "The Caribbean" was officially launched in Amsterdam on Thurs-

The author himself was at the American Book Centre in Amsterdam because he is unfit to travel due to his critical illness, but he was well represented by his publisher Liesbeth Heenk of Amsterdam Publishers.

Heenk said the 300-page book in English, which Gelt Dekker started working on in July 2017, was hard to classify under one genre because it contained different elements of history, travel, fiction and fantasy.

The main character in the book embarks on a fictitious sea vovage around the Caribbean, stopping at many of the islands where he gets involved in all sorts of adventures. He is not alone on his boat. Accompanying him are Anansi the Spider, the trickster from the famous Caribbean tales, and The Flying Dutchman, doomed to sail the oceans forever and harbouring a terrible secret.

Together, they seek to establish the truth about the history of the Caribbean. Along the way, they encounter famous pirates and unpick tales of untold riches, but also retrace the steps of the region's slaves, and how events in Europe, the American colonies and Africa sealed their fates.

"In fact, failure is not an option, as the people of St. Maarten are depending on us to be prepared for whatever disaster may come our way. This morning we are gathered here to firstly reflect on what occurred pre. during and post the passing of the strongest hurricane to this island we call home and we are also here to ensure that we not only pay keen attention to our shortcomings but also to build on the foundation of positive actions that were executed.'

"We not only bring together members of the EOC, but we also include key external stakeholders. There are organizations and departments in and out of Government that were not written into the previous planning and preparations, but definitely after our experience of last year need to be either at the table or fitted in structurally into the existing EOC organisation, as we must fill those missing gaps.

"We must seize the moment and change the way things have been done in the past. The final objective is critical and a departure from business as usual, the establishing of a National Integrated EOC Operation Plan. Upon taking office, I was told we have a disaster plan. The question is, where is it?

"The answer is the "Rampenplan" that is a written law and policy that does not speak to the average citizen. Going forward, I have made the establishing of a National Disaster Plan a priority and it must be completed ASAP. Collectively we have an obligation to the citizens of St. Maarten to provide pertinent information in preparation of any disaster.

'This National Disaster Plan has to be the bedrock and reference manual to any communication plan being executed in the future. If done properly, I expect this National Disaster Plan to be a working document that can be adjusted yearly by any ESF group as the circumstances may require. As a written document it can used as a reference in Government, our schools and the private sector to prepare for

"These plans are commonplace in other countries; therefore, St. Maarten should not be any different. In fact, we always pride ourselves on being the best. day, Friday.

Well, today I declare that we will have the best comprehensive National Disaster Plan."

# SDGs, Dispute Regulation, Venezuela topics at IPKO

(SDGs), the Dispute Regulation for the Kingdom, the situation in Venezuela and the consequences for the Dutch Caribbean are three main topics that will be discussed during next week's Inter-Parliamentary Consultation for the Kingdom IPKO.

The IPKO will take place in The Hague from Tuesday, May 29, to Friday, June 1, with Parliamentary delegations of the Netherlands, Aruba, Curacao and St. Maarten as participants. Under the chairmanship of Chairman of the Second Chamber's Permanent Committee Alexander Pechtold, the delegations will discuss common themes

The IPKO will open on Tuesday morning in a plenary session at the First Chamber, the Senate. Addressing the delegations will be Senate Chairwoman Ankie Broekers-Knol, after which the heads of the delegations will speak.

After the opening, the delegations will talk about the recent developments in the individual countries. The situation in St. Maarten and the reconstruction will be a focus of attention. The sustainable development goals (SDGs) delegation.

THE HAGUE--The Sustain- and their status of impleable Development Goals mentation in the countries will be discussed. The SDGs are the objectives drafted by the United Nations (UN) for sustainable development worldwide.

On Wednesday, the delegations will talk about the Dispute Regulation, which has been a source of discussion within the Kingdom for many years. Also on the agenda that day are the political situation and economic crisis in Venezuela and the consequences for the islands.

As part of the theme "Sustainable economic development," the delegations will visit Wageningen University and a waste-processing company on Thursday.

IPKO ends on Friday with the signing of the agreements list and a joint press conference by the leaders of the four delegations.

The St. Maarten delegation is headed by President of Parliament Sarah Wescot-Williams of United Democrats (UD). Members of Parliament (MPs) Silveria Jacobs of National Alliance (NA), Wycliffe Smith of St. Maarten Christian Party (SMCP) and Roland Brison of United St. Maarten Party (US Party) are part of the
